MESSAGE FROM ONE ALL

India, especially the state of Tamil Nadu, has shown tremendous improvement in education indicators such as literacy rate. However, there is still a large population of young people experiencing insidious problems: violence at home, unequal treatment of and opportunities for girls, early marriage, and substance abuse.

One All Trust was founded in 2016 to improve the lives of youth in underserved communities in Chennai. The organization uses the sport of ultimate frisbee as a tool to run at-school and after-school values education programs for boys and girls 13-17 years old. One All believes that life skills education and mentorship are essential for adolescents to resolve conflict, build empathy and become resilient young adults. These children are changemakers who will improve their lives, their families' lives, and the lives of future generations.

A journey of 2019 was different from the past 3 years. One All became more matured through learning experience and challenges.

We would like to thank the supporters who joined the journey of One All with belief for the cause. Without such supports, the children's growth through One All has been possible.



CHENNAI OPERATIONS

OVERVIEW

2019 was a special year for Chennai operation, especially Community program. We started a new community program in Srinivasapuram- one of the largest fishing community in Santhome. Around 15 to 20 children come three times per week for our program. Around 15 children have been going through gender sessions since February 2019. Entire one year covered topics on gender norms, expectation, stereotype, separation etc.

Although our partnership with Olcot school did not continue this year, we partnered with Sharanalaya Montessori school and two corporation schools. We learnt to focus on developing more school partners to create fun learning experience for the children to grow in next year.



COMMUNITY PROGRAM

CHENNAI

15 children have undergone intensive gender sessions in 2019. We used visual aid, debate, discussion, worksheet and journal to share individual ideas to learn each other.

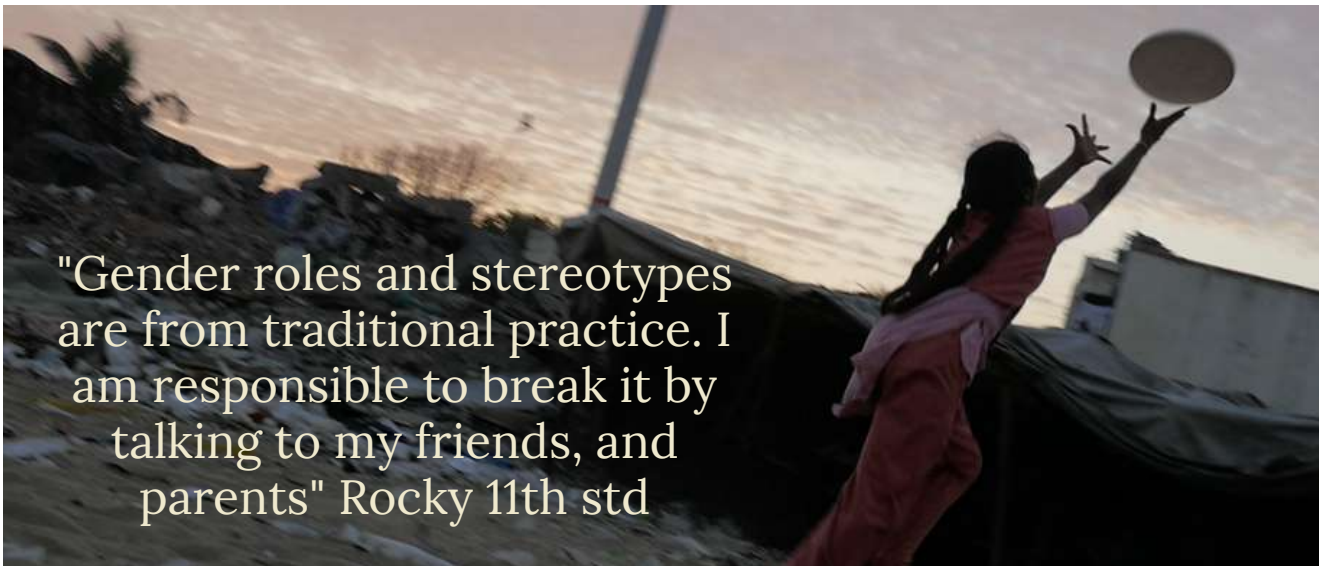

GUDALUR OPERATIONS

OVERVIEW

Our operations have achieved stability in our second full year of working with the adivasi community of Gudalur. Our team of facilitators and youth leader have made tremendous progress in their own training as well as with building trust with the children. This year saw us move closer to our annual goals for each of our programs. The children have built healthy friendships, improved their time management, reduced using bad language, are very regular to sessions and have stopped chewing tobacco during sessions.

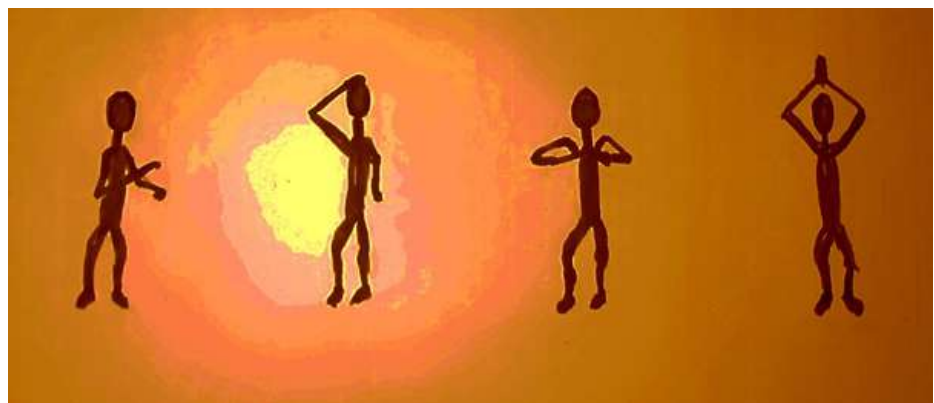


COMMUNITY PROGRAM

GUDALUR

Our community program at Erumad still has 25 regular children attending from 3 surrounding villages. These children have also convinced their friends to join our sessions. We conduct sessions here twice a week. Now, the children themselves call our facilitators and confirm the sessions instead of the other way around - this is a huge step towards responsibility for them. This shows the level of trust they have with the facilitators. This year we focussed on the five aspects of “Spirit of the Game” - rules knowledge and use, body contact, fair mindedness, communication, and positive attitude and self control. The children named their team “PUYE”, which in Paniya means “where the river joins the ocean”. They chose this name because they want their team to grow in skill, talent and exposure like the river joining the ocean.

Our team drew the hand signals we use in the sport in their adivasi drawing style!

DAY CAMP WITH “TIKS”

We are trying to build a programme that draws from the experience of the Ultimate Frisbee community in India as well. As a step towards this, 5 players from a major ultimate frisbee club team in Bangalore - “That Idli Kaal Soup”, visited our program and helped run a day camp at Erumad.

The focus of this camp was to improve our PUYE team’s frisbee skills, communication skills and provide exposure to them. The children and the visitors had an amazing time.

The sessions at SSA school attracted so many that we had to split into two groups - one for the younger children (6-11 years) and one for the older children (12-16 years)! The younger children requested us for this themselves because they want to get better at the game before they can play on the full field with the older children. This shows intention to practice and improve their skills.



NEW SCHOOL PROGRAM!

We started a new school program in September 2019 at Fatima Girls Higher Secondary School in Gudalur. We run our sessions twice a week (Mondays and Fridays) for around 45 adivasi and non-adivasi girls from the 6th std at this government aided school.



STORIES OF CHANGE

GUDALUR

Through our local partner organisations ACCORD and VBVT, our facilitator Parvathi got the opportunity to visit Germany with two others from the adivasi community. They were hosted by the "Adivasi Tea Projekt" in Germany. While she was there, she spoke to them about ultimate frisbee and our programs in Gudalur. She conducted a session with children at a school in Germany as well.

“ When we teach our kids (in Gudalur), it is easier - especially because of the language. I was worried when I went there that I would not be able to communicate with foreigners. But I had help with translation into German. After I conducted the session there I became confident that I could do this anywhere. I realised that if I know something, I need to teach others - there is no point of keeping the frisbee in my bag - I can interact with others through it.

TEAM "PUYE" GOES TO BANGALORE!

The Ultimate Players Association of India (UPAI) hosts a National Club Team Championship every year from September to February. Last year there were 124 teams that participated in this across all divisions and regions. Our team "PUYE" took part in one tournament of the championship held in October at Bangalore. For most of them, it was the first time traveling out of Gudalur. The facilitators helped them take part in "Spirit Circles" with the other teams after their first couple of matches, but by their last match the children themselves were speaking openly to their opponents. Their confidence grew, they made new friends, ate new kinds of foods, and had a glimpse at how people lead their lives in the city. They became more vocal in supporting their own team and the opponents - they realised the importance of encouragement and support. They witnessed amazing sportsmanship, felt pride in their own abilities. They returned from this trip with a renewed motivation to work hard and improve themselves in the game - especially in their knowledge of the rules.





I was immensely impressed by the PUYE team's unfazed excitement, positivity and intense determination, regardless of the score board. What was most striking was that the women/girl players seemed to take the lead for most points. We were truly kept on our toes and were absolutely humbled by the game and spirit of the youngest and their oldest members. I was floored by the Parvathi and Badichi's cool leadership of the team too!

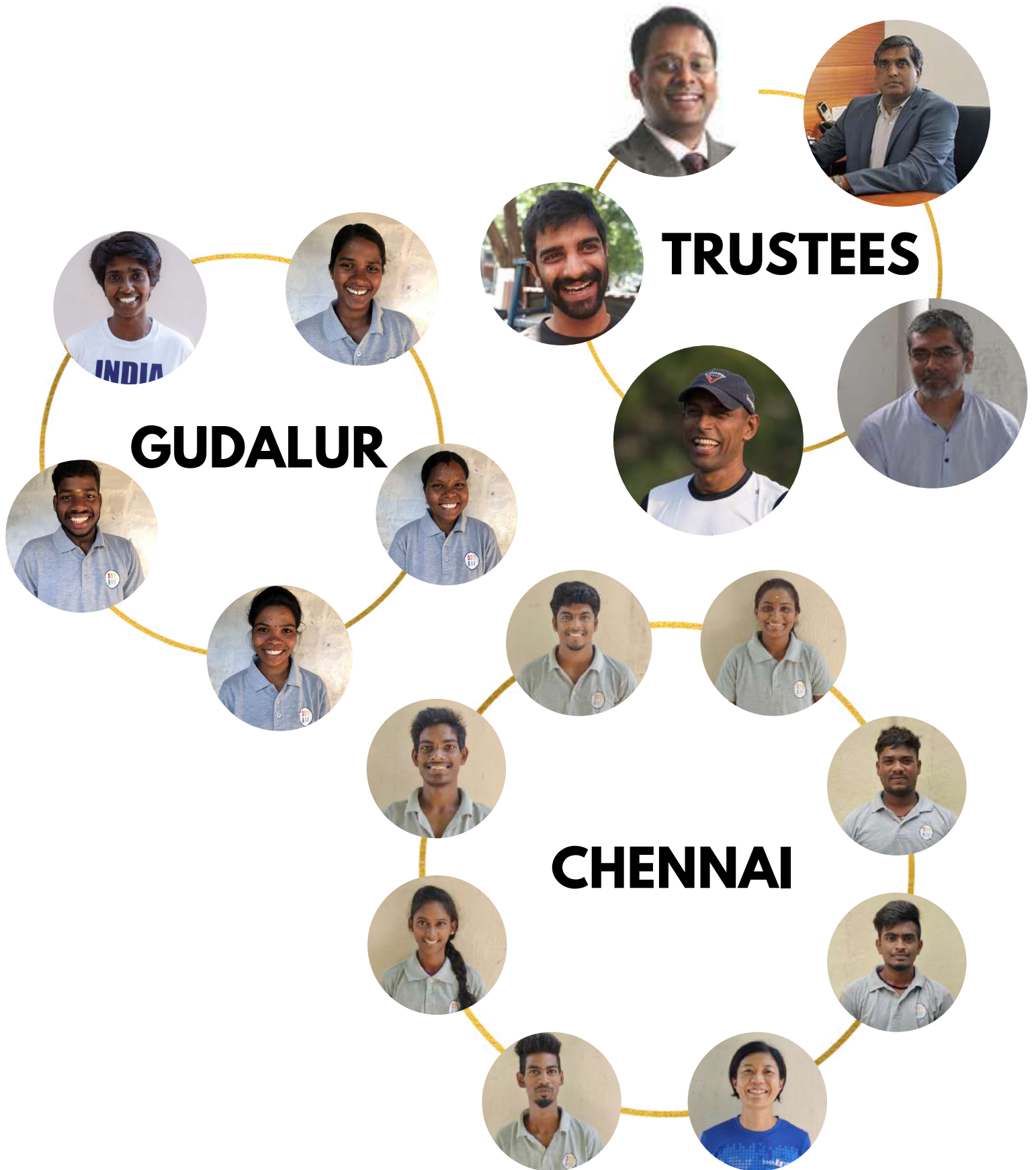
