A MESSAGE FROM ONE ALL

2021 was the second year of living in a pandemic. There was a tremendous hope that it would be better than 2020. Meanwhile, we were accustomed to a 'new-normal' such as online classes, limited capacity to function businesses, curfews and restrictions, etc. Chennai operation were able to slowly resume our life skill education through mixed gender sport programs at the communities. We started engaging with two more communities – KK Colony and Ayodhya Nagar, this year. We noticed that many people in our communities hesitated or were against taking vaccines. In order to fulfil their needs, we worked with community leaders, partner organizations and the Chennai City Corporation to spread correct information about vaccinations.

We used 2020 to not only pivot but to also learn different methods to teach life skills, to build better organizational systems and developed partnerships with NGOs who would like to integrate our One All curriculum into their operations. We have realised that by partnering with like minded organizations to train their facilitators at their locations directly, we can more effectively reach communities in other parts of the country.

In Gudalur, this year was for us to internalize, evaluate and restructure our strategic approach in engaging with the tribal communities. We have learnt to decentralize our focus by introducing a Fellowship Program in Gudalur. The program envisions to develop youth from the villages into community sports facilitators and future leaders.

This year, our founder, Varsha Yeshwant Kumar was selected as an International Future Leader by the Australia Council for the Arts, and Azim Premji Philanthropic Initiatives (APPI) came on board to support our Chennai operations for 3 years. We are still living in a pandemic and face uncertainty; however we would like to thank people and partners who have showed us immense support.

CHENNAI OPERATION OVERVIEW

When schools started providing their own online classes and as Covid restrictions slowly lifted, we decided to resume our community programs. Initially, we were very nervous – Will the children come to our sessions? Will resuming sessions backfire and cause community issues if anybody gets Covid? We resumed one program at Srinivasapuram to test. The children who were physically and emotionally repressed in the last 1.5 years were so excited to come to sessions! We expanded our operations to two more communities through our partner, Pudiyador.

We noticed that there was a lack of correct information about vaccinations. People forwarded unfiltered (mostly false) information via online messages and social media. It created irrational fear and concern toward vaccinations. With our partners, community leaders and Chennai corporation, we delivered accurate information to promote vaccination.

Through all these efforts, we have reached the highest number of beneficiaries in three communities since we started One All!



COMMUNITY PROGRAM

CHENNAI



Apart from our life skill education through sport program, we started providing menstruation workshops in order to break social barriers.

According to our study and home visits, when girls reach puberty, they were forced to stay inside the house. The girls themselves were unaware of the changes in their bodies, periods and hygiene. There are misconceptions and inaccurate information – myths about periods and cultural practices during periods. We partnered with EcoFemme who manufactured cotton pads (based in Auroville) and designed a very interactive menstruation curriculum. We piloted this with 13 girls this year and we have received tremendous support from the community leaders to complete the module and work with more girls.



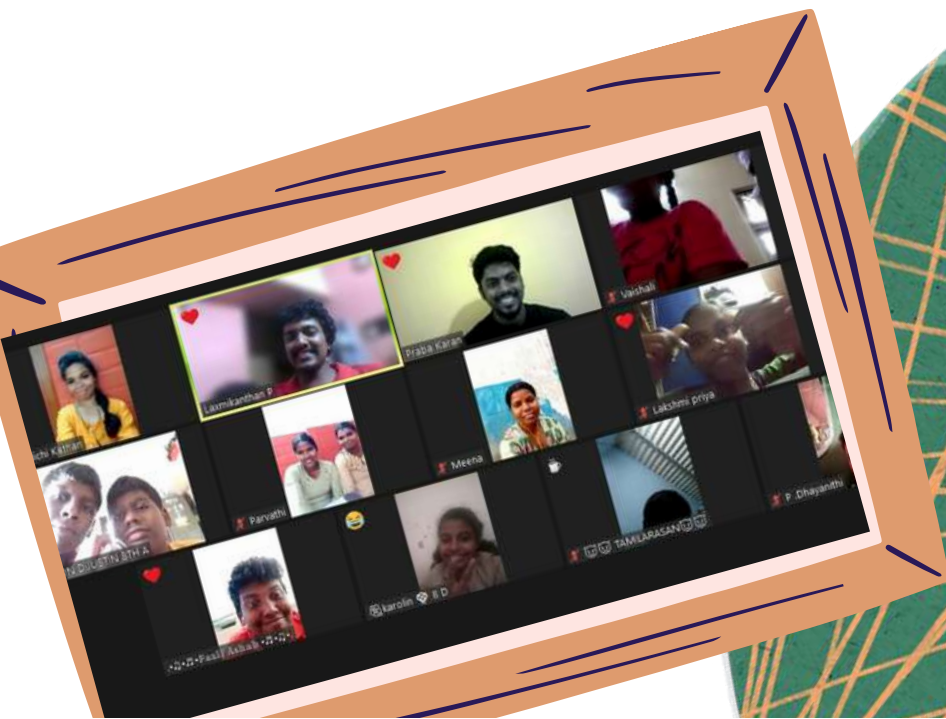

SCHOOL PROGRAM CHENNAI

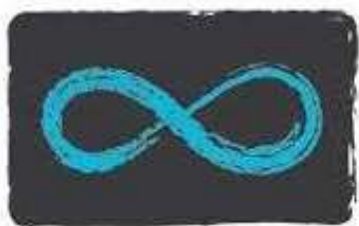
In the beginning of the year, schools were still shut. Slowly the schools reopened but only for students in and above 10th std. The rest of the children continued to attend online classes. We were very concerned about the wellbeing of these children who attended online classes for a whole day and about the quality of teaching as well. Teach For India, who also had similar concerns agreed to partner with One All to conduct physical activities online - to give the children and teachers a break from academics.



FACILITATOR TRAINING

THROUGH PARTNERS

During the lockdown (2020-21), we designed a facilitator training program with a vision for scaling up through potential partners. The facilitator trainer would travel and stay at the geographic locations where our partners based at. We aim to create a sustainable model by providing 3 month of Facilitator Training Program to the potential facilitators from the partners such as school teachers, youth, community mobilizers, influencers, etc. Our pilot in Vanavil (Nagapattinam) was a huge hit and we trained 8 teachers and 118 children from 6 villages. We also partnered with Kshamtalaya in Udaipur, Rajasthan to train 12 community mobilizers and 109 children from 5 villages. We have partnered with 3 other organizations to start our facilitator training program in Odisha and Karnataka in 2022-23.

The Nilgiris district, being a biodiversity hotspot and home to a large percentage of tribals, had very strict COVID protocols even after the cities started opening up. So we had to adapt to what the communities needed since we could not engage with our children in person. We helped our local partner organisations conduct livelihood surveys, kept in touch with our children through the phone and worked on facilitator training.

During this time we restructured our approach to community engagement to better deal with challenges we faced pre-pandemic. This is how the Adivasi Fellowship for Community Facilitators was conceived. The purpose is to decentralise our team to directly work from villages rather than spend effort and time to travel in this hilly terrain. 2021-22 was a time to research, prepare and partner with like minded organisations in order to launch the Fellowship at the end of the year.



ADAPTING TO THE COMMUNITY'S NEEDS - AN INTERACTIVE COMMUNITY RADIO

There was an urgent need to disseminate authentic information about COVID, build awareness and knowledge to counter the misinformation being circulated. We needed to support the community to overcome their hesitancy to take vaccines and to adhere to all safety and preventive measures and most importantly to ensure well managed home care protocols for less severe patients.



In this crisis we partnered with AMS, ACCORD and GramVaani to create a centralised communication system for community mobilization, awareness building and rapid COVID response. Gram Vaani has developed Mobile Vaani - an intelligent Interactive Voice Response (IVR) based participatory media platform. Operated through simple mobile handsets, the Mobile Vaani IVR systems provide a feasible option to reach communities, especially those living in rural areas with low internet access. We started a dedicated IVR line called "ADIVASI KURAL" (indigenous voice) that has audio programming in 4 tribal languages (Paniya, Bettakurumba, Kattunayakan, Mullukurumba) as well as Tamil and Malayalam.

COMMUNITY PROGRAM GUDALUR



We restarted our community program in Erumad after the government lifted restrictions on the usage of public playgrounds. The children were eager to start playing again and we saw many new faces who joined us!

Two of our beneficiaries have children of their own and they have convinced their families that they need to attend our sessions.

20 children and youth are part of the Frisbee team PUYE from Kootat, Kotramangalam and Vellachal.

We conduct sessions twice a week.



SCHOOL PROGRAM GUDALUR

We started a new school program this year with 4th standard children from Vidyodaya School (Gudalur).

Our goal and that of the school teachers is to reduce hurtful teasing and verbal fights among the children. 20 children regularly attend our sessions here twice a week.

The teachers were very happy with our observations of the children and the impact we were having that they have requested us to take on another standard from the next academic year!





We started engaging with children from Sarva Shikshya Abhiyaan (Gudalur) once schools reopened in early 2022. The children were so starved for activity during the lockdown that almost 50 children came to the sessions we conducted thrice a week!

We split them into Junior and Senior groups.



ADIVASI FELLOWSHIP PROGRAM

GUDALUR

This year we have been preparing to pilot our Adivasi Fellowship for youth (18-30 years) - an immersive inter-sectional program to build a team of passionate, self-confident and resilient facilitators who empower the next generation.

By the end of this Program,
Fellows will

- **develop critical-thinking and leadership skills.**
- **become ultimate frisbee facilitators**
- **gain a team that supports and challenges each other**
- **have a forum to discuss larger issues**
- **gain employment post the Fellowship to start One All sports-for-development(S4D) centres to mentor children in their own villages**
- **gain exposure to issues regarding health, education, finance and digital information; and actively engage with their communities to solve them**



FUNDRAISERS

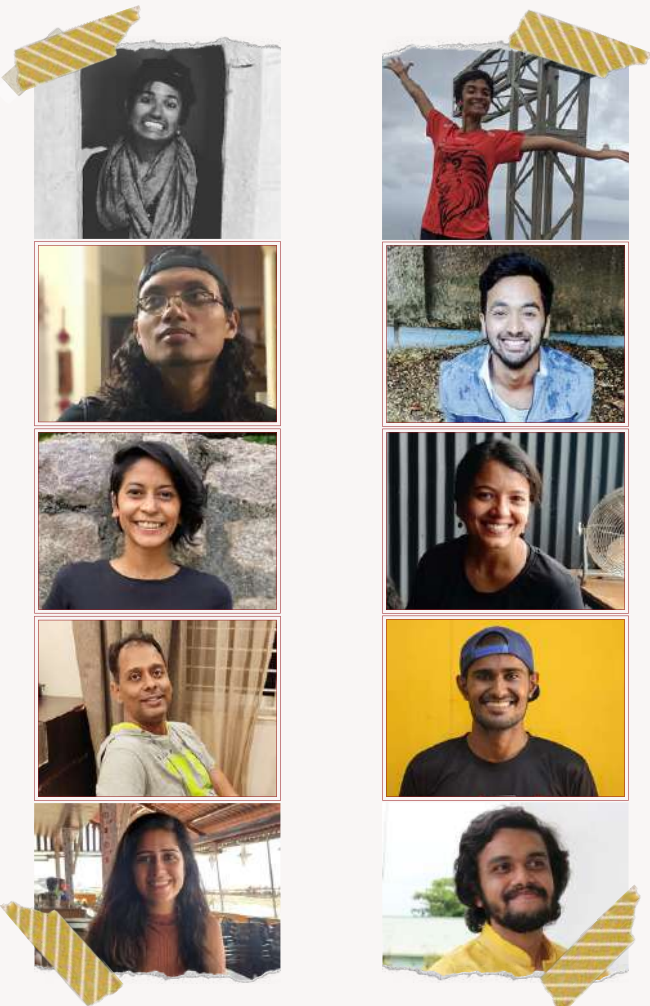
We reached 26,300 people who had not heard about us before!
